- 6) Ongoing resident complaint review
 - a) Follow-up on EV Charging
 - i) A new parking spot has been opened for residents to plug their car in by the ADA parking at Cottonwood parking
 - ii) An email will be sent to residents to notify residents of the available parking/charging and to notify them that if they park in the handicap parking they are risking getting a ticket
 - iii) New charging stations are being installed and will be ready in the next couple months
 - b) New parking
 - i) Set up the parking situation to encourage 900 court residents to park in the new parking lot behind the court to allow the 800 court to have parking available to them.
 - c) Visitor Parking
 - i) Residents are parking in the visitor parking lots due to the lack of parking spaces making it so visitors cannot park at the village
 - ii) Wendi will reach out to commuter services to have them check the parking spots and issue some sort of warning to residents parking in visitor parking.

 - iii) Administration will be monitoring the dumpsters for a while and then make a plan to educate residents to place their trash in another dumpster instead of placing it on the ground around the dumpster
 - iv) Proposal: If we move the second dumpster to the new parking lot behind the 900 court to allow an even distribution between waste going into one dumpster.
 - (1) Wendi will look into this and see if it is possible
 - e) Communications regarding construction
 - i) Fall of 2025 the graduate housing will be finished
 - ii) Fall of 2026 the family housing will be finish and the 800-1000 courts will be closed

- iii) The newsletter was our way of sharing construction updates, due to residents' concerns and complaints about not being informed in a timely manner.
 - (1) Requested to have a better communication going on between the construction company, administration and residents.
 - (2) Administration is working on getting the construction company to communicate in a more timely manner.
 - (3) A timeline is being worked on to phase out the west village apartments to send out to the residents to be able to make plans about it.
 - (4) Having more play-by-play updates about the current demolitions and construction plans and things going on so that residents can plan to change their plans if needed due to the construction in the area.
 - (5) Residents in the older apartments don't consider the new apartments as an option to move into, and they are going to mass move to the east village.
